- A. Discussion and Possible Action on Cases RZON2511-008 and VAR2601-001 - Request to Rezone Property Located at 631 Marietta Road from O-I (Office-Institutional) to GC (General Commercial) and Associated Variance Application - Zoning Administrator Steve Green

Mr. Green provided background on the case. Staff recommended approval of the rezoning and variance cases as requested with the following conditions:

- 1) The owner/developer shall dedicate sufficient property to provide a right turn lane into the parcel from Marietta Road. This right-of-way dedication shall be approved by the City Engineer during the Land Disturbance Permit application process.*
- 2) The building elevation facing Marietta Road shall have a store front finish or the appearance of a store front as approved by the Canton Design Review Team.*
- 3) Unfinished or smooth-faced concrete masonry shall be prohibited as an exterior building material.*
- 4) Wall mounted lighting shall be prohibited on any building.*
- 5) Sight lighting shall face inward toward the property and shall not cause a disturbance to neighboring properties of the motoring public.*
- 6) The property shall be developed in substantial accordance with the applicants Letter of Intent dated November 30, 2025, and attached hereto as "Exhibit A."*
- 7) The requested buffer reduction and setback reduction shall be as shown on the applicant's site plan stamped "Revised 3-3-26" and attached hereto as "Exhibit B."*

Mr. Roach moved to approve the request to rezone from O-I to GC and the variance request with all staff recommendations, and additionally that the property only be used for retail and office, and of the office it will not be used for vape shops. Mr. Tolan seconded the motion. The motion passed unanimously.
