*Mr. Phillip Price presented the case as the Applicant's representative. Mr. Price stated that the request is to remove two trees from the property. Commissioner Stanton joined the meeting. Ms. Walker-Bunda explained that the request included painting the existing steel posts that sit against the building Pure White, five stretched fabric decorative awnings that would be at the top of the windows at the exterior facades, two mesh screen panels to visually separate their patio space from an adjacent storage space, and infill panels installed at the base of the staircase which goes to the patio space above the tenant space.*

*Commissioner Rich made a motion to approve the request with the condition that the exterior fabric fixed window awnings are not approved as presented. Commissioner Sellers seconded the motion.*
