Housing Initiatives Director Ken Patton provided information regarding a concept plan submitted by Lew Oliver for the potential housing project located at the old fire station property near Laurel Canyon, accessory dwelling units, and recommendations for a down payment assistance program. City Engineer Bethany Watson discussed updates on transportation and capital improvement projects such as the City's parking deck, Highway 140 projects, traffic signal improvements, Transportation Master Plan, Harmon Park, North Street improvements, and Georgia Department of Transportation projects. Manager of Economic Development & Tourism Angie Busby spoke about collaborative projects such as a destination marketing strategy and website, Cultural Arts

Master Plan/Public Arts Master Plan, Economic Development Business Guide, hosting the Downtown Development Association 2023 Conference, and Main Street GEMS status project. Police Chief Stephen Merrifield reviewed department staffing and open positions, updates on training, request for a change/increase in Special Events pay, future capital items, and handgun transitions. Utility Engineer Dave Hatabian provided updates on the Water Pollution Control Plant schedule, water treatment plant, utility relocations, and lift station improvements.
