Crown Castle has been requested, Crown Castle Fiber LLC. ("**Crown**"), or an affiliate of Crown to perform the work described below (the "**Work**") with respect to a Crown distributed antenna and Fiber system. Accordingly, this notice (this "**Notice**") hereby notifies The City of Canton that Crown will be performing the Work at the cost described in the attached Network Services Quotation. Crown Castle will be utilizing the joint duct system that Georgia Power Company (GPC) is building due to an aerial to underground conversion. The City of Canton shall be responsible for 100% of Crown Castle's cost difference outside of the GPC construction. GPC will directly bill The City of Canton for the labor and material cost to install (1) 4" duct for Crown Castle's to convert an aerial fiber to underground per scope outlined below:

SCOPE OF WORK:

Upon the completion of the GPC work and the duct released to Crown Castle, Crown Castle will convert existing aerial fiber to underground.

This work includes the following task:

- Overlash New Cable
- Install-Fiber, tracer wire, guys & anchors, snowshoe bracket, U guard
- Daily crew trucks
- Splice prep and Splicing (Crown must have NTP prior to being able to submit for a service outage approval. Currently approvals are taking up to 90 days to acquire)
- Relocate Crown Castle Aerial fiber into joint trench. 4" Conduit will be supplied and installed by GPC and turned up at riser poles. GPC will directly bill City of Canton for actual cost
- Crown Castle will supply and install 3-way interduct inside 4" conduit, fiber, handholes, conduct a fiber audit and splice at 100% cost paid by City of Canton for a lump sum.

Please confirm acceptance of the Work by signing below and returning the executed Notice to my attention at the email address above. Crown will notify receipt of the executed Notice, and Developer or any other responsible party will need to pay as soon as possible from the date of such notification to Crown for the cost of the Work. Work will not start until this payment is received.
