## 10. Old Business

- A. Discussion and Possible Action on Cases ANNX2408-003, RZON2408-005, CUP2408-004, and VAR2408-005 - Request to Annex and Rezone 14.91 Acres along April and Lucky Streets for the Development of a 198 Multi-Family Residential Project along with a Conditional Use Permit and Variances - Zoning Administrator Steve Green

***Zoning Administrator Steve Green stated that at the last meeting Council had several questions for the applicant. Those were forwarded to the applicant's representative. Mr. Green stated at this time the representative has not received all the answers to those questions and has requested a deferral to allow for additional time to get that information. Councilmember McGrew made a motion to deny the annexation. Councilmember Johnson seconded the motion, and it was approved unanimously.***

- B. Discussion and Possible Action on Cases ANNX2407-001, RZON2407-004, MP2407-003, and CUP2407-002 - Requests to Annex, Rezone, Gain a Conditional Use Permit, and Master Plan Approval along Prominence Point Parkway for a Residential Development - Zoning Administrator Steve Green

***Mr. Green stated that answers to Council's questions from the last meeting have been answered and an email with those responses was forwarded earlier today. Mr. Green noted that staff has recommended denial due to the requested density being twice than what is proposed in the Comprehensive Plan. Councilmember Yawn made a motion to deny the annexation. Mayor Pro Tem Waterman seconded the motion, and it was approved unanimously.***

*Theatre Events and Facilities Director Kristin Norton Green reviewed the scope of work for the project and noted that a grant has been awarded for \$20,000. Councilmember Yawn made a motion to approve the construction agreement with Calm Water for the Canton Theatre exterior renovation project. Mayor Pro Tem Waterman seconded the motion, and it was approved unanimously.*

- D. Discussion and Possible Action on Approval of the Downtown Master Plan - City Engineer Bethany Watson

*City Engineer Bethany Watson stated the City has been working on this master plan for about a year and the Downtown Development Authority recently approved the plan at their meeting. Councilmember Roach discussed concern for Project ID 19 (Main Street Road Diet). Councilmember Roach requested that this plan be removed from the master plan. Ms. Watson stated that the concept plan was included based on public input. Discussion was had among Council, City Manager, City Attorney, and staff regarding what the possible effects of removing the concept plan would have on other projects listed within the master plan. Staff will reach out to Modern Mobility Partners to see if removing Project ID 19 will alter other projects or alter any data analysis and what would be the timeline and cost associated. Staff believes answers could be received prior to the January 16th Council meeting for further discussion. Councilmember Tolan made a motion to postpone action on the Downtown Master Plan until the January 16th meeting to allow for Modern Mobility Partners to provide additional information. Councilmember Yawn seconded the motion. The motion passed with all members except Councilmember Roach voting for the motion. Councilmember Roach voted against the motion.*

*Ms. Watson stated this item was brought up at the last meeting under the City Manager's Report. A pump at Lift Station River Green 8 went out. Ms. Watson stated the pump had been in place for 25 years. The lift station is currently operating with only one pump. Mayor Pro Tem Waterman made a motion to approve the emergency pump replacement at River Green 8 Lift Station from Xylem Water Solutions USA, Inc in the amount of \$147,611.06. Councilmember Yawn seconded the motion, and it was approved unanimously.*
