5. Old Business**A. Kiosk Project Update**

The kiosk has been delivered to Public Works and was installed today, February 4, 2026. Final programming is being completed by RovelQ.

B. Chocolate Walk – February 7

The Chocolate Walk is scheduled for Saturday, February 7, 2026 from 11:00 am to 5:00 pm. Ticket sales are ongoing and 2 sponsors for the event have been secured. At this time 243 tickets have been sold, and 28 businesses and 10 restaurants/bars have committed to participating the event. Tickets are \$20 and do not include any drink tickets.

C. ShamRock Shuffle – March 14

The ShamRock Shuffle is scheduled for Saturday, March 14, 2026 from 12:00 pm to 6:00 pm. At this time there are 12 businesses that have confirmed to participate. The Shuffle is slightly different this year compared to last year. Approximately 300 cups that remained from last year will be distributed at La

Cantania with the purchase of a specialty drink. There will not be any cost or sign up for the event. Specialty drinks will be available for sale at the participating businesses. Main Street will fund the cost of the music and shuttles.

D. Downtown Canton Business Club

There was discussion on when to hold the meeting and if the meeting will rotate between businesses. The first meeting will be at the Jones Building with follow up discussion with the business owners on their preference having the meeting in the same location, hosting a meeting in their business or sponsoring a meeting.
