President Bill Magruder called the meeting to order @ 1:30 PM. The minutes from the October 21, 2014 meeting were presented for additions/corrections. Member Joyce Swindell noted that her absence from the October meeting was not entered into the minutes. Frances Vaughn moved to accept the minutes with the correction, seconded by Joyce.
