ORDINANCE OF THE CITY OF CANTON

WHEREAS, the City of Canton is authorized by the constitution of the State of Georgia to adopt rules, regulations, laws, and ordinances protecting the public health, safety and welfare of the citizens of the City.

THE CITY OF CANTON ORDINANCE PART III, DEVELOPMENT CODE, APPENDIX A, ZONING ORDINANCE, ARTICLE C, District Regulations, BE AMENDED AS FOLLOWS:

That **Section 8-8-C-62.05 CBD general commercial,** of the ordinances of the City of Canton, Georgia is hereby amended by amending sub-section B. Conditional Uses by adding a new conditional use as follows:

(4) Automotive paint and body shop

Furthermore,

That **Appendix A. ZONING AND USE CHART**, shall be amended by adding a new Use, Automotive paint and body shop, and such use shall be designated as "Conditional" in the CBD general commercial zoning district.

All ordinances or parts of ordinances or regulations in conflict herewith are hereby repealed.

Should any section or provision of this ordinance be declared invalid or unconstitutional by any court of competent jurisdiction, such declaration shall not affect the validity of the ordinance as a whole or any part thereof which is not specifically declared to be invalid or unconstitutional.

It is the intention of the Mayor and Council, and it is hereby ordained that the provisions of the ordinance shall become and be made part of the Code of Ordinances, City of Canton, Georgia and the section of this ordinance may be renumbered to accomplish such intention.
