102. Proposed use of the subject property is for church use.

RECOMMENDATION

The Canton Planning Commission recommended approval of CUP1502-001 during the public hearing on March 16, 2015. The recommendation was given with the condition that the approval should only be for Life Church Canton.

REPORT-IN-BRIEF

Jonathan Becker, Worship Director of Church of Isaac's Keep has filed an application seeking conditional use approval for 210 East Main Street, Suite 210. The proposed use is a church and related activities. During the public hearing held by the Planning Commission on March 16, 2015 no one spoke either for or against the proposal. Concern was raised as to the use of the lower level as a nursery area. The applicant was in attendance at the public hearing and heard the concerns raised. He was also notified via e-mail on Monday, March 23, 2015 to contact either the Fire Chief or Fire Marshal and possibly the Building Official to discuss this issue. The Planning Commission recommended approval with the suggested condition that approval shall only be granted to the Church of Isaac's Keep. Any subsequent church at the location must go through the conditional use process.


