*Ray Deluca - Resident and representative of Rock Creek Estate homeowners, Whispering Hills and Puckett Creek communities, and those who live along Shoal Creek Rd., presented concerns of the homeowners about the added traffic along Honey Dew Lane which is already a dangerous road. Should it be used as access for the second entrance to Soliel there could be an increase of more than 400 vehicles on the road a day.*

*Bruce Ayer - Resident on Puckett Creek Dr. expressed concerns about the increase of on Honey Dew Rd. based on future building expectations.*

*Jay Clark - Representative of developer SEC, reported that SEC has met with Soliel HOA and is working on the amenities matter although plans are not yet final.*

*Doug Dillard - Attorney with Pursley, Friese, Torgrimson, representing SEC, agrees with the recommendations of the Planning Commission except for conditions 14.*
