#### 11. City Manager's Report

City Manager Billy Peppers asked Council for a vote to approve the replacement of a length of Old Ballground sewer pipe which is scheduled to be replaced in the future, but should be replaced now while Quiktrip already has the area under construction. The cost will be \$110,000.
