Please Accept This Correspondence as a Request, Pursuant to City Code Sec. 2-86(a) of Division 2 of Article II of Chapter 2 of City Code, that I would like for there to Added to The City Agenda for Council Consideration an Item to Conclude Previous Business from a Previous Council Meeting to Adopt The Proposed Cherokee High School 'School-Safety Zone' Map that was Prepared by The Cherokee County School District.

The City of Canton Legislative Council did, on November. 20, 2014, Adopt all 'School-Safety Zones' Prepared by The Cherokee County School District via Resolution except for The Cherokee High School 'School-Safety Zone' Map. 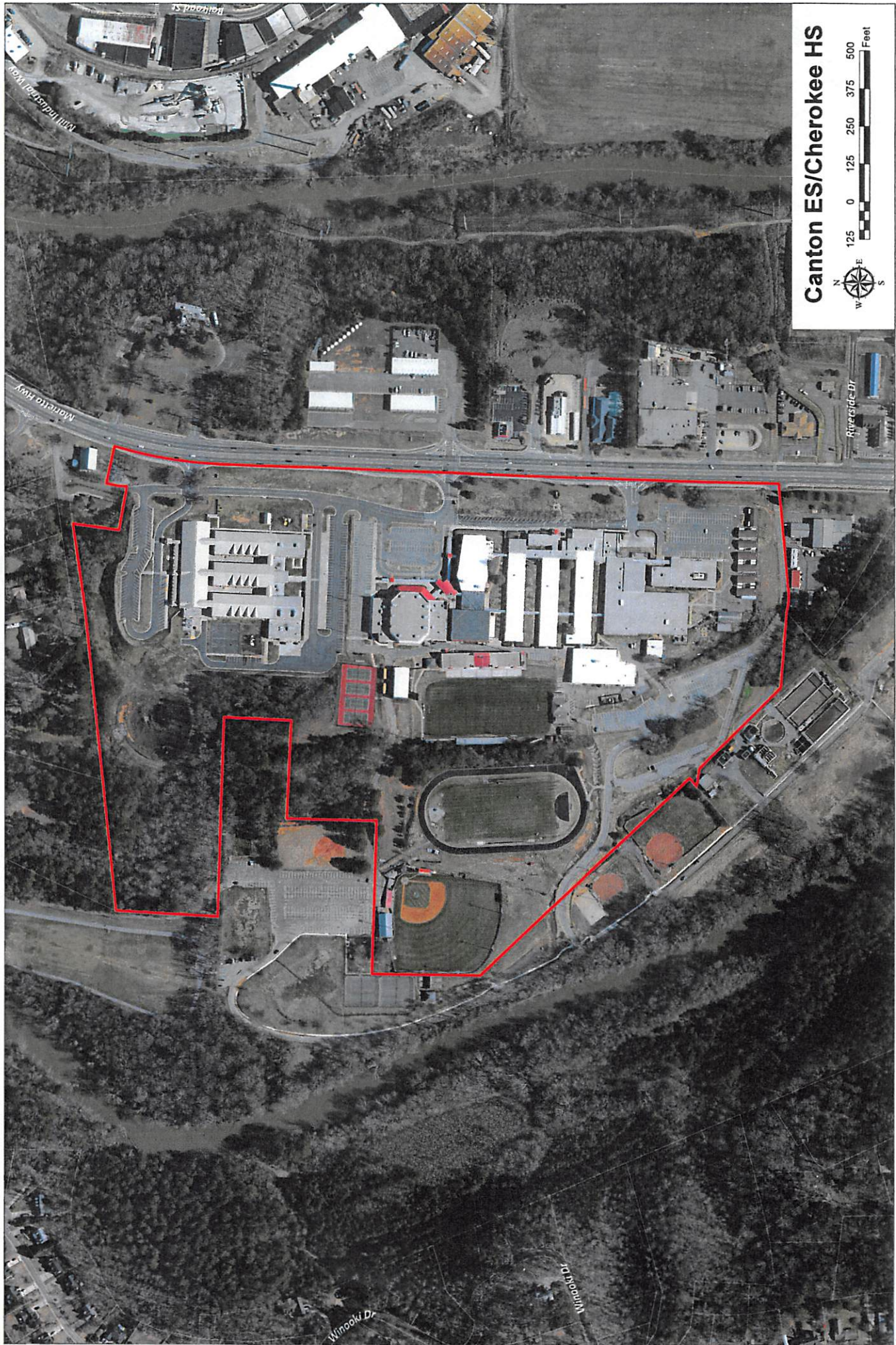
