**I. Call to Order**

The meeting was called to order at 6:05 p.m.

**II. Approval of Minutes – January 3, 2017 and February 6, 2017**

**III. COA1703-001 – 121 West Main Street – Panera Bread Company – Request for new construction**

Mark Harris presented the application. Mr. Harris discussed the site location. Mr. Harris discussed the exterior elevations of the proposed building. Mr. Harris talked about the outdoor area including the fireplace and patio. HPC members expressed concern for the copies submitted as they were not well printed and not legible. Staff member Green discussed all City departments that review applications. Mr. Harris read the submitted paperwork to the HPC members. Members discussed proposed brick. Mr. Harris stated he would like to bring in brick samples for members to see. Staff member Patton discussed submittal procedures for the Oversight Committee and suggested the members look at color renderings.

**IV. COA1703-002 – 251 West Main Street – Demolition of existing structure**

Mark Harris presented the application. Mr. Harris stated the house is commonly referred to as “The Cagle House”. Mr. Harris stated he offered the house to the City and the Historic Society. Staff member Patton talked further regarding the City’s inspection of this property. Member Seller asked about saving the house and using it for

commercial use. Mr. Harris stated it would take a large amount of money to restore it and his intention is to use that area for parking. Member Sellers showed photographs of older homes in Woodstock and Roswell which were restored and saved. Mr. Harris stated the City gave him the number of required parking places which is why they came to the decision of taking down the house. Mr. Harris stated no house movers would guarantee the house would not fall apart. Mr. Harris and members discussed the location of parking for the development.

Member Shelnett made a motion to table the application until the April meeting. Member Price seconded the motion. Discussion ensued regarding the possibility of saving the house and receiving a reduction in the parking space requirements. Members and Mr. Harris discussed the cost of restoring the property.
