Dana Cox briefed the board on the recent meeting with the magazine editor and publisher Jodi Drinkard and Rebecca Johnston and the board's marketing committee on May 7. The group's discussion included having less articles and more call to actions; clearer and trackable ties to social media; online version to have hyperlinks to Explore Canton for further details about businesses featured. The group also talked about a revised distribution plan of the magazine to include a postcard mailer to 12,000+ identified addresses to "save the date" for the next magazine edition release with a QR code to online edition and to mail a physical copy of the magazine to a set of 1,500 newly identified addresses.

Dana Cox provided a status update on the kiosk in downtown project. Main Street has approved funding the kiosk contingent upon Council approval. The board discussed the logistics of the kiosk, ie, updates, QR codes for more information, ADA accessibility. The board decided to delay a vote on approval of funding until Council receives more information on the project at their May 15 meeting and officially approves the project.
