4. Old Business**A. Kiosk Project**

The City Communications Department sent an email to the Main Street Board with concerns about the kiosk project and requested action or clarification from the Board:

1. Need the board to concretely determine if law offices/service businesses will be on this.

Law Offices/Service Businesses will be included

2. Some business owners would rather have a directory with images and videos of their business rather than having a wayfinding map. A QR code will be added so that people can scan to pull up a Google Maps route directly from the kiosk to the business to compensate for the absence of direct wayfinding. A sub-committee will meet to address this issue

3. The City's IT department has stated the public WIFI network in Downtown is not secure. If IT cannot reconfigure the network security for the WIFI, another piece of network equipment (Cradle Point mobile router) will be required to be installed inside the kiosk. The cost of this would be around \$300. IT has requested that Main Street cover the cost of the equipment and IT will cover the \$30 monthly fee.

Main Street will cover the one-time cost of the additional equipment

4. If the Board wants a full-blown wayfinding map + directory, different software than the one originally proposed will be required, which could affect pricing.

5. *The Communications Department indicated this project will take months to complete on the design end. It's not as simple and plug and play. The Department wanted to emphasize this to the Board.*

6. *Once it is determined who will be included in the directory, it would save a lot of time if the names and emails of contacts are forwarded to the Communications Department.*

7. *Overall, the Communications Department wants to ensure there is a clear understanding of what the Board wants from this project. It is a very intensive project for the initial start and should smooth out over the course of time, but it'll be more difficult if there's constant feedback.*

Velinda Hardy updated the Board on the first Farmers Market event of the year. Attendance at the event was over 3,000 people, which nearly doubled the number of attendees from last year. The Farmers Market will continue for 14 weeks, ending on August 30, 2025.

The GEMS application was submitted on Friday, May 30, 2025.
