**D. Downtown Director's Comments**

*Velinda Hardy provided updates on the following: There were approximately 5,000 people in attendance at First Friday, the farmers market will begin on May 30, 2026 and will continue for 14 weeks. The Canton Downtown Breakfast Club will meet in May and resume on August 13, 2026. There were plans to have an after-work mixer in June and December but the Board decided to eliminate the June Mixer and only have the December Holiday Mixer. The GEMS presentation is scheduled to made at the June 4, 2026 City Council Meeting.*
