Defining Blight

 Georgia Constitution: "at a minimum, property that constitutes endangerment to public health or safety"

Defined Blight Conditions

(Two or more required)

Shall not be deemed Blight solely for aesthetic conditions

- Violation of Applicable Codes
- Unfit for human habitation
- Life Safety / Drug Crimes
- Repeated Illegal Activity

- Abandoned
- Unsanitary/Unsafe Conditions
- Defacement of property



Blight Tax



Applies to Residential and Commercial

Does not inloude dwelling occupied as primary residency by atleast one person.



NOTICE TO OWNER OF HEARING UNDER CHAPTER 54, ARTICLE VIII: COMMUNITY REDEVELOPMENT TAX INCENTIVE PROGRAM

You are hereby notified that the building official has prepared a report indicating that your property located at and identified as Tax Parcel is being maintained in a blighted condition as defined in Chapter 54, Article VIII of the Code of Ordinances of the City of Canton, Georgia. You may inspect and copy the building official's report at City Hall during the hours of 8:30a.m to 5:00 p.m.
You are also hereby notified that a hearing will be held on before the City Manager at (location of hearing inserted here). At the hearing you will be given the opportunity to present evidence and testimony to dispute the findings of the building official.
If it is determined that your property is being maintained in a blighted condition, then your property will be assessed additional property tax based on a millage rate equal to seven times the millage rate otherwise applied to your property, until the condition is remedied. Declaration Notice:
NOTICE OF DESIGNATION OF PROPERTY AS BEING MAINTAINED IN BLIGHTED CONDITION
Following the hearing held on, your property located at has been designated and declared as maintained in a blighted condition, as defined by Chapter 54, Article VIII of the Code of Ordinances of the City of Canton, Georgia and is now subject to increased taxation.
You may remove the designation/declaration by taking the steps to remedy the condition of the property as set forth on the attached list.
You may appeal the designation of blight to the city council by requesting a hearing within 30 days from the receipt of this Notice.
