This included a concept of the Hickory Flat Highway and Marietta Road roundabout as well as a new roundabout at Marietta Road and Dr. John T. Pettit. She also noted the need for feedback in density and possible uses. Raul asked about the existing roadway and impacts of construction. Bethany noted that the current roadway would remain open as the new roadway and bridge are built. Tammy asked about the*

possibility of dealing with the flood zone on the Canton Village site knowing that the new roadway may take advantage of the front of the site. Bethany to find out what that process is.
