A. **Stefanie Forte - Canton Historic Haunts Tours**

*Stefanie Forte provided the Board with information on Historic Haunts Ghost Tours. After a 4-year hiatus, she wants to bring back ghost tours with event more experiences and community input. She is anticipating a summer relaunch, which will be her 20-year anniversary in the paranormal field; Former tours were conducted from the gazebo with about a dozen stops, including the historic courthouse, Bizarre Coffee, cemetery, and the history center.
