Ms. Pendley presented the item. A 48-inch metal corrugated pipe in the area has it lifespan. Centrifugally sprayed in concrete piping solution is the best option. Staff will seek action on May 7. Ms. Pendley stated the estimates were \$57- 66K. Mayor Grant noted this type of repair was used in other parts of the City. Ms. Pendley stated the improved pipe should last many years.

- B. Discussion and Possible Approval of Fuel Surcharge on Sanitation Rates - Waste Pro

Mr. Ingram presented the request from WastePro as they could not attend. The request was initially for a 15% surcharge for diesel fuel increase. Mr. Ingram noted that he informed WastePro about the reduction of excise taxes in the State for at least the next 60 days. WastePro agreed to only seek a 10% surcharge for fuel. Mr. Rusbridge noted that WastePro has to ask and the City should approve based upon what is extraordinary and what is reasonable. The Council discussed the possibility of making the approval time-restricted. This item will come back before the City Council on May 7 for consideration.
