## 4. Public Input

*Lisa Marie Haygood and Stephanie Gibbons provided the Board with some information on the upcoming Chick-fil-a 5K run, the largest in the state. It was pointed out that the race is a Peachtree qualifier, draws more than 3,000 participants, as well as many supporters, and is one of the largest in the state.*

*were provided. Mr. Ingram mentioned to the Board that the City will distribute funds allocated to the Board before its next meeting, and in turn ask that a reimbursement back to the City is approved. This will help clarify the Board's balance sheet.*

## **10. Discussion and Possible Action for Advertising Opportunities**

### **A. Historic Canton Magazine**

*It was noted that Historic Canton Magazine was currently working on the upcoming publication. The Board directed staff to make sure that the publisher was directed to provide sufficient notification ahead of time for their next publication. This would provide the Board with ample time to consider as well as an opportunity to provide information and directions on articles should an engagement be reached. Member Cox moved to fund the current publication the requested \$14,000; Member Farley Seconded; Motion carried*

## **11. Sponsorships and Applications**

**A.           Murph's Surf Shop**

*Discussion was made regarding last year's approval. Member Farley moved to withdraw/rescind that approval; Member Ramsey seconded; Motion carried with Member Cox abstaining due to a potential conflict of interest*

**B.           Chick-Fil-A 5K**

*The organizer originally asked for \$6K, although they have indicated that there is a spot for their \$10K Platinum sponsorship level. Member Cox mentioned that the Board should be mindful of how much of Canton Tourism's funding is spent on advertising and marketing. Member Cox moved to approve \$6K as applied, and staff to make sure that we are maximizing our advertising efforts on this project; Member Farley seconded; Motion carried.*

**C.           Peaberry Film Festival**

*Lauren Johnson provided the Board with some information regarding the funding request for \$10,000. The event is to be held in October. Most of his expenses were for marketing. Member Cox mentioned that we need to make sure that CTB is the 'presenting sponsor', given the \$10K request. Member Cox suggested that the Board consider a \$6K sponsorship. Member Ramsey moved to sponsor \$6K; Member Farley seconded the motion; Motion Carried*

**D.           History Cherokee Derby Days**

*The organizer requested a \$5,000 Sponsorship for Derby Days. Kathy Lyles and Judy Bishop provided a brief explanation of the yearlong project to host this event. Member Cox moved to approve the \$5K as presented; Member Ramsey seconded the motion; Motion carried.*

**12.    Board Introduced Items**

*Member Cox mentioned that we should provide a monthly stipend that City staff could use at their discretion for marketing activity on behalf of the Board. Jacky provided the Board with some general information on online marketing costs. Member Cox mentioned to the Board that we could create a formal proposal for 'Explore Georgia'. This subject will be discussed further with a Marketing Committee once established.*
